US Department of Labor, American Staffing Association sign Ambassador Alliance to continue protecting temporary workers' safety, health

August 9, 2022

WASHINGTON – An eight-year alliance between the U.S. Department of Labor's Occupational Safety and Health Administration (OSHA) and the American Staffing Association (ASA), established to improve the workplace safety and health of temporary workers, continues to be valuable and productive. OSHA and ASA signed an Ambassador document on August 9, 2022, in recognition of ASA's demonstrated commitment to collaborating with the agency to improve safety and health practices and programs in American workplaces.

The goal of an Ambassador is to continue the longstanding relationships between OSHA and Alliance participants through ongoing outreach and information-sharing, and training.

OSHA and ASA first signed an alliance in 2014 and it was renewed in 2016. Their collaboration has resulted in several successful initiatives and activities, including:

- Promotion of OSHA's Temporary Worker Initiative to raise awareness among host and staffing employers of safety and health issues that impact immigrant and vulnerable worker populations across multiple industry sectors (General Industry, Shipyards, and Construction).
- Free webinars that discuss a series of OSHA Temporary Worker Initiative Bulletins, including a recent webinar about the agency's newest bulletin on outdoor/indoor heat prevention. Other webinar topics include respiratory protection, noise exposure and hearing conservation, and communicating with workers about hazardous materials.
- An ASA safety committee that works with companies to ensure temporary workers' voices are heard and to identify workers interested in safety and health careers.

"Temporary workers are, by law, afforded the same workplace protections as permanent employees," said Assistant Secretary of Labor for Occupational Safety and Health Doug Parker. "We are grateful for ASA's continued dedication to helping OSHA educate temporary workers about their rights and train host employers and staffing agencies on their responsibilities to protect the safety and health of this vital part of the workforce."

ASA, founded in 1966, is the voice of the U.S. staffing, recruiting and workforce solutions industry. ASA and its state affiliates advance the interests of the industry across all sectors through advocacy, research, education, and the promotion of high standards of legal, ethical, and professional practices.

Through the Alliance Program, OSHA works with organizations such as trade and professional associations, labor unions, educational institutions, community and faith-based groups, and government agencies to share information about OSHA's initiatives and compliance assistance resources with workers and employers, and educate workers and employers about their rights and responsibilities.

The Murphy Family has been operating Coastal Construction in Florida for five generations and is a significant contributor to the growth of their communities. Having been brought up in the family business, Patrick is no stranger to the intricacies of the industry. He is, however, a bit of an anomaly when it comes to his experience and approach.

Patrick rejoined the family business in 2017, yet before that he worked as a CPA and then spent time as a U.S. Congressman. While in Congress, he thought a lot about the advancement of technology, the growth of the sharing economy, and how AI could affect the evolution of our country. He also grew frustrated with the pace of change.





"We're in the middle of a technological revolution, in many ways similar to the industrial revolution; there's a lot of disruption happening, a lot of very frustrated people that are uncertain about the future."

Faced with a fresh start upon returning to home, he embraced his leeway to be creative and began to question how he could apply his ideas in ways that could improve the family business. Tasked with boosting efficiency, he focused his attention on streamlining one of the largest drivers of overhead in the construction process: pre-construction. Considering this, Patrick set out to develop software that automated the take-off process so that estimators could focus on higher value tasks, and thus Togal.AI was born.

Having developed and launched software that simplifies the take-off process, he is now turning his attention to refining the program's interface and expanding its cloud-based sharing and collaboration capabilities in addition to expediting importing features of plan sets. In addition, Togal.AI is developing automation for the mechanical, electrical, plumbing, and structural aspects of pre-construction analysis, develop code compliance information. They recently launched a new exporting feature in addition to a drawing revision comparison tool.

"Nothing slips through the cracks and it creates that transparency."

The past few years witnessed the impetus that forced many people outside of their comfort zone: zoom meetings, remote work, and the use of cameras and drones to monitor progress. In light of this, there has been an increase in productivity that points to the potential for even more efficiencies to be found.

Even though Togal.Al's software can be utilized by large and small contract purposes, it can be particularly valuable for smaller subcontractors, trade partners, and general contractors. They will be able to gain access to, and bid on 10 times more work than they would have been able to before. In addition, they won't have to rely on trade partners to do pricing and quantity checks. That "go-no go" scenario is made easier. With a click of a button, they can view all the build project's needs and discern whether or not the bid is worth chasing in the first place!

Despite Residential Slowdown, Construction Adds 13K Jobs in June

Buoyed by continued gains among nonresidential specialty trade contractors, overall construction employment increased by 13,000 jobs during June, the Bureau of Labor Statistics reported. The industry's unemployment rate decreased slightly, to 3.7%, from May's 3.8% rate.

One industry economist believes that the latest data shows that contractors will continue to be challenged to find enough workers to staff current and future projects.

"With industry unemployment at a record low for June and openings at an all-time high for May, it is clear contractors can't fill all the positions they would like to," Ken Simonson, chief economist for Associated General Contractors of America, said in a statement.

As was the case in May, specialty trade contractors provided the greatest job gains in June. The sector added 11,800 positions overall during the month, with 11,400 new jobs coming from the nonresidential sector, while residential contractors added roughly 400.

Also showing gains during June was the heavy and civil engineering construction category, which added 4,500 jobs overall.

While all construction sectors reported jobs gains in May, that was not the case in June. According to BLS, overall employment in the building construction sector declined by an estimated 3,900 jobs. That overall decline was the result of a loss of 4,500 jobs in the residential construction sector, combined with a modest gain of 600 positions among nonresidential building contractors.

"Although nonresidential contractors were able to add employees in June, the industry needs more as demand for projects is outpacing the supply of workers," added AGC's Simonson.

The Associated Builders and Contractors noted that, altogether, nonresidential construction employment increased by 16,500 positions overall as a result of gains in the nonresidential specialty trade, nonresidential building and heavy and civil engineering construction sectors.

Calling the June employment report "a welcome respite from a sea of bad economic news," ABC Chief Economist Anirban Basu noted in a statement that "inflation has induced many people back into the labor market in order to offset elevated costs for essentials and luxuries alike."

Still, Basu added, "This does nothing, however, to dim the risk of recession," with the Federal Reserve likely to continue increasing interest rates.

"Higher borrowing costs working in conjunction with lofty materials prices and rapidly rising worker compensation mean that the threat of significant numbers of project postponements and cancellations remains firmly in place," he said.

Construction's 3.7% unemployment rate reported for June 2022 is less than half that of the 7.5% rate reported back in June 2021.

Overall, the U.S. economy added 372,000 jobs in June, with the unemployment rate staying steady at 3.6%.


